The Neurology Clinic is open one day per week and is a general neurological clinic where movement disorders represent around 20-25% of our population. It is clinically oriented without current research program. Tremor disorders represent 40-50%; Dystonia 10-15%; Ataxia 5-10%; Gait abnormalities 10%; Drug-induced 5%; Psychogenic disorder 5%; Tics 2-3%. We see an average of 20-25 patients per day at this clinic.
